• As noted as an addendum to the minutes of 5th September, Reg Ruffell sadly passed away on Thursday 8th September. Following the meeting the Chairman did write to Reg and Janet Ruffell to advise them of the County's decision. The letter was received after Reg had passed away. Janet Ruffell contacted the Chairman to thank County for the honour. The funeral has taken place which was attended by the Chairman and a number of the committee. Gary Chandler has been asked to purchase a plaque to present to Janet Ruffell.

3b) Treasurer's matters

Gary Chandler was unable to attend as he was out of the country on business. He did send a report which was read out at the meeting:-

1. England Athletics refund. We are still to receive the refund in respect of the 'additional' entry fees that we were forced to pay for the Inter Counties Track and Field match at Bedford earlier this summer, despite at least 6 chasers. Dave Staines as Chairman has agreed to contact EA to complain, requesting immediate re-imbursement. Amount involved is approximately £500.

At the meeting Dave confirmed that he has spoken to Chris Jones (CEO, England Athletics) and the matter is being followed up.

2. XC relays on 24th September generated a net profit of £2,202 (income of £3,150 and expenses £948). Profit is down from £2,310 generated last year which was due to the fact that Essex Medics were double booked and we had to find an alternative supplier. They charged £350 (Essex Medics last year charged £120)

Dave Staines personally thanked Ron Dawson for organising the event. Ron had encountered a number of administrative problems leading up to the day. There were problems with the field area which meant Ron had to change the course and due to industrial action the loss of the car park at the school.

There was a large entry on the day and it was agreed that it was a good move to change the fixture to a September date.

It was reported that there were problems on the day when seniors warming up for the event got in the way of the juniors who were competiting in their race. Concern was also raised that some teams failed to change over correctly which meant their new runner starting before the incoming runner had finished. This was difficult to police and it was suggested that at next year's event that batons should be used. Matter to be referred to the Endurance Committee for their consideration.

Dave Staines also congratulated Claire Levey and her officials who did a fantastic job on the day.

- 3. Gary has not yet received any invoices from Alistair Gillan in respect of the work on the new County website.
- 4. Final plea; can anyone with any expenses relating to this financial year email details to Gary by the 7th October. After that date the accounts will be passed to the auditor for their annual review.
